Welcome

Welcome to the 2024 "The State of Bipartisanship" report produced by Majority in the Middle and powered by Plural Policy bill tracking software.

Majority in the Middle is a 501(c)3 non-profit organization and an objective, outside force for systemic change that seeks to improve transparency, participation, and civility within Minnesota political and civic life.

This report is designed to analyze bipartisan bill authorship as one important reflection of effective collaboration. This effort identifies where cooperation happens, elevating the people who are leading the way, and collecting replicable ideas to cultivate a healthier political environment -- in St. Paul and in state capitols across the country.

Our first report in 2023 set the baseline and uncovered what we named *hidden bipartisanship*: the work being done across the aisle that doesn't get a lot of attention, and that isn't reflected in the outcome of large omnibus bills when final votes fall along party lines.

Biennial Factors

Our 2024 report is the first opportunity for a year-over-year comparison of bill introductions and committee hearings. However, this is not an apples-to-apples comparison, as the Minnesota legislature operates on a two-year biennial cycle.

In a biennium, there are factors that distinguish the first and second years, so different dynamics are at play.

- Year 1 is the longer budget session.
- Year 2 is a shorter session, usually focusing on policy and capital investment. The second year is also an election year for House members, and for Senators in years ending in 2, 6, and 0.

This report becomes logistically tricky when trying to articulate what happened over the two-year cycle. Bills that were introduced in the first year are still in play during the second year. In order to keep our year-over-year reports consistent, bill authorship as it relates to legislators are measured as of adjournment on the last day of each session. Biennial totals may not be the sum of individual years, due to changes of first-year bills during the second-year sessions. (Since authorship for the committee analysis is based on authorship at time of hearing, that data is not affected.)

Ultimately, annual comparisons are interesting, but biennial comparisons are what will be more informative. We look forward to continuing this work and identifying trends over future bienniums.

Why we created this report

Surfacing hidden bipartisanship and elevating examples of bipartisan behavior are part of the organizational mission of Majority in the Middle.

It's a fact that the cooperation and collaboration happening at the capitol doesn't often get public attention - the fight does. Dueling talking points, outrageous floor speeches and social media skirmishes get much more attention than crafting nuanced public policy and developing relationships.

As an organization, we do what we can to shine more light on the bipartisanship that IS happening.

A reality we contend with: not every legislator wants attention for their bipartisan work and not every legislator finds bipartisanship to be an electoral benefit in their district.

We would argue that any bipartisanship is still important. Why? All legislators, even those who run unopposed, have people in their district who didn't vote for them. Representing all the citizens in the district, not just the ones who voted for them, is their duty.

What this report is not

Although comparisons will naturally occur, this report is not an effort to label legislators as best or worst.

Bipartisanship is complicated. Bill authorship is just one measure. Since authoring legislation is essential to legislators' job, it is an important measure.

There are many ways a legislator can work across the aisle that are not captured in this report. It is our position that any efforts by legislators to cross the aisle and build relationships should be celebrated.

To ensure this report is objective, more subjective forms of collaboration by legislators are not measured. We are exploring opportunities to expand the scope of the report in future years and will do so if resources allow.

Vote totals, which bills passed and which did not, are also not included in this report.

There are several paths for a bill to become a law: passed as a standalone bill, as a numbered amendment, or as part of an omnibus bill or conference committee report. Following the path for an individual bill can be difficult. In the interest of time, we did not include that information in this report. However, we are exploring this issue and hope to release an addendum if we can quantify results.

Executive Summary

Bipartisanship is nuanced and difficult to measure. Bills are the "deliverables" of legislative work, and arguably the most important. This report measures bipartisanship as it relates to bill hearings in committee, and bill authorship by individual members.

Election years and unusual situations can often increase partisanship at the capitol. This year (the second in a trifecta that is outside the norm for Minnesota) was no exception.

In 2024, an election year for the House; a change in leadership, an arrest, and a campaign for congress in the Senate, all added pressure to bipartisan efforts. Additionally, this report may have been of influence.

But when the dust settled on the 2023-2024 biennium, here's what we learned: if you look at topline results, it seems like bipartisanship went down year-to-year. But when you look at individual committees' and members' data, you'll see effort being made. This report will celebrate that effort.

Executive Summary Statistics

Overall bipartisanship in the Minnesota legislature declined in 2024 compared to 2023. Yet, data shows that many committee chairs and individual legislators actually demonstrated more bipartisanship.

- The total percentage of minority-led bills getting a hearing went down from 36% to 31% in the Senate, and held steady in the House at 11%
- Bipartisan bills introduced in 2024 fell from 45% to 38% in the Senate, and 27% to 26% in the House
- The proportion of hearings given to minority-led bills went up in seven Senate and 11 House committees
- The proportion of hearings given to bipartisan bills went up in two Senate and 11 House committees
- By the end of the biennium:
 - all but two of the 134 House members had sponsored and/or co-sponsored bills with members of both parties
 - all 67 Senators had sponsored AND co-sponsored bills with members of both parties

Why we should care about bipartisanship

Bipartisanship is hard, messy, and subjective. It's also essential.

We believe that political division in the United States is the overarching problem of our time. If you care about cost of living, mental health, immigration, democracy, climate change, school funding, you should care about political division. Big topics of justice and freedom and liberty and safety - that we all need to tackle - are off the table if we don't reverse this trend.

Issues don't get solved when we're divided. Instead, power and public policy swings back and forth on a pendulum, from one extreme to another.

Divisiveness means that issues that didn't used to be controversial are now partisan. Our culture and political system need to incentivize and reward compromise if we are going to make progress on challenging problems.

Unique challenges in 2024

The Senate is usually more stable than the House because of four-year terms instead of two-year terms. The razor thin 34-33 margin was a special challenge. And then three additional challenges for the majority arose during 2024.

- In December 2023, Senator Kelly Morrison launched her campaign for Minnesota's third congressional district. With no other candidate seeking the DFL endorsement by the end of February the question whether Senator Morrison would resign her seat persisted throughout the session.
- Two weeks prior to the first day of session, Majority Leader Kari Dziedzic announced while she would remain in the Senate, she was stepping down from leadership to focus on her cancer battle. Senator Erin Murphy was elected by the caucus to take the role.
- In April, during the legislative Passover break, Senator Nicole Mitchell was arrested for first-degree burglary which prompted a number of procedural motions, calls for her resignation and confusion over her status.

The way the session ended - with rushed motions and shouting in both chambers - was jarring to almost everyone involved. Many capitol watchers say that this conduct was unprecedented, and that the institution is forever changed. This may or may not turn out to be true, but no one would say that it was "politics we can be proud of." Since the very last hours of session didn't change the items that we analyze in this report, this will be our only mention of the situation. However, we will find other opportunities to engage on the topic, since the relationships and trust that are required for future bipartisanship may have been affected.









Committee Hearings

Committee Hearings

This section of the report examines the authorship of bills that received a hearing in a committee during the 2023-2024 biennium.

When a bill is labeled as DFL or Republican based on the party identity of the chief author, a binary picture emerges. But bills in Minnesota have more participation beyond the chief author. A Senate bill can have up to five total authors, a House bill can have up to 35. Party affiliation of the co-authors matters as well, because a minority member is unlikely to put their name on a bill they – and their constituents – might view as "too extreme."

To illustrate total authorship, we created two graphs for each committee: one showing bill hearings classified by the party affiliation of the chief author - red or blue - and one showing the same bills, with total authorship taken into account.

As you'll see, including shades of purple to represent the proportions of red *and* blue authors paints a very different picture. We believe it is a better illustration of the influence and participation by members of each of the political parties – especially when, in this era of omnibus bills – the red-blue divide is often more stark when it comes to final votes.




with an increase in proportion of minority-led bills getting hearings 2023 vs 2024


with an increase in proportion of minority-led bills getting hearings 2023 vs 2024

with an increase in proportion of bipartisan bills getting hearings 2023 vs 2024



Individual Legislators

How do individual legislators influence bipartisanship?

Unlike most roles at the legislature that are based on seniority and hierarchy, individual legislators have enormous agency and power to create and cultivate bipartisan support for bills.

They do this by actively including colleagues across the aisle on their own bills, as well as signing on to bills authored by others.

These connections may be built on shared interests, from practical similarities of districts (e.g., shared county or school districts, similar industrial base) to personal (relationships, similar personal or family backgrounds, professional experience, legislative interests). Based on these commonalities, members can actively work to build these connections and collaborate on legislation.

Ultimately, legislators are free agents with election certificates.

Ideally, individuals will recognize and use that agency to build trust within their caucus while also building and nurturing relationships across the aisle - as well as down the hallway with members the other legislative body. Every bill in the House needs a Senate companion and vice versa, so bicameral relationships are also important.

Bill authorship by individual legislators

For each member of the legislature, we made two calculations.

First, the proportion of co-authors from either party included on bills for which legislators are chief author*, and therefore in charge of the bill.

Second, how frequently legislators signed onto bills as a co-author that were carried by members of their own party versus those bills carried by members across the aisle.

The individual information is presented as a numerical count. However, different legislators have different preferences on the number of bills they carry and/or sign onto, and sometimes their bill load is affected by other roles in the legislature.

As a reminder, it is our position that bipartisan cooperation is nuanced, and bill authorship is just one piece. There are many ways a legislator can work across the aisle that are not captured in this report.

*Our analysis subtracted out bills for which the legislator was the sole author. Including party identification for those bills seemed to paint an overly partisan picture of the entire dataset. Those bills are still included, but show as grey, instead of red, blue, or purple.

Top-level findings from the Senate (see full graphs p. 90-157)

Partisanship - within this analysis of individual members and their work on bill authorship - continued to be less stark in the Senate than in the House by the end of the biennium.

Senate individual chief authored bills

- Every member of the Senate had at least one member of the opposite party signed onto the bills they carried as the chief author.
- Eighteen members of the Senate had bipartisan co-authors on at least 30% of their chief-authored bills.

Senate individual cosigned bills

- Eight Republican Senators had DFL chief authors on at least 50% of the bills they signed onto. Another 5 had DFL chief authors on more than 40% of the bills they signed onto.
- Every member of the Senate signed onto at least one bill chief-authored by a member of the opposite party.

Top-level findings from the House (see full graphs p. 158-294)

After the first year of the biennium, partisanship - within this analysis - looked more stark in the House than the Senate. However, while there's still more partisanship, more members of the House also seemed to make an effort to cross the aisle in 2024.

• At the end of 2023, 22 DFL members and two Republican members had only signed onto bills chief-authored by a member of their same party.

By the end of the biennium, that number was 12 DFL members and zero Republican members. Of the 12 that changed, eight of those co-authored one bill each. Three co-authored two bills, and one co-authored six bills.

• At the end of 2023, 14 Republican and three DFL members only had bills they carried alone or with members of the same party.

By the end of the biennium, that number was halved: seven Republican and one DFL member only had bills they carried alone or with members of the same party. Of the nine that changed, five of those added a member of the other party to one of their bills. Two added two, one added four, and one left the legislature.

Outcomes & Recommendations



Outcomes

We hope this report will accomplish two things:

First, to give support and acknowledgement to those legislators who are working across the aisle. We see you and we thank you for work that often goes unnoticed and unappreciated. Keep it up.

Second, to the public: despite what you may see in the news, or on social media, or from political campaigns - not all politics is divisive. Not every legislator sees enemies on the other side of the aisle. If you look hard enough, you can see the good work that's being done behind the scenes.

Legislators often hear from people who are really happy or really unhappy about an issue. They hear from advocates who are being paid to persuade them. They hear from political staff and campaign operatives who want them to toe the party line. They don't often hear from constituents who want compromise and collaboration – which, polling shows, is what most Americans want.

The best thing you can do to support legislators working across the aisle is to let them know you care about bipartisanship, and support them with your voice and your vote. (And if bipartisan cooperation is something you want to model, we encourage you to run for office. This work needs more champions.)

Recommendations

This year we are including a number of recommendations that came from our observations, current and former legislators, staff, lobbyists and other individuals, to try and make the legislature a better place to serve and work.

Make Space for Bipartisanship

- There seems to be an inverse relationship between the time spent in committee, and time spent on the floor. Caucus
 leaders and committee chairs should ensure sufficient committee time for discussion and amendments. Time is a precious
 and fixed resource in the legislative session. While floor sessions are significant, they almost always go as expected with little
 chance to change an outcome, and they're mainly a stage for members to offer amendments, information and opinions.
 Committees, on the other hand, are where the real work is done and where all members, experts, and citizens can weigh in.
- Majority and minority members should be represented on committees "substantially in proportion" to their percentage representation in the full body. When the majority holds an outsized number of committee seats (and thus votes), it fuels the sense that the process is "rigged." This doesn't require a rule change, only a closer adherence to the spirit and letter of current rules.

Manage the Floor

- We would highly encourage both chambers to process as many stand-alone bills as possible. Along with abiding by the spirit and letter of Minnesota's single subject rule, this allows a demonstration to the public of all the agreement and common ground that does exist. We aren't calling for abolishment of all omnibus bills, that would be silly, but we do call for more judicious use of that tactic.
- Set reasonable limits on floor debate. This isn't just about dissuading minority filibusters. Less time per bill gives the opportunity for more bills to be considered. One of the arguments for Omnibus bills is the limits on floor time. This would help overcome that objection.

Evaluating the rules without knowing for sure which party will be in the majority is an opportunity to employ a veil of ignorance. We would highly encourage members of both chambers to sit down together and hash out rules changes that everyone could live with – as members of the majority or the minority – BEFORE NOVEMBER, while control of the chambers is being determined by the voters.

We have limited the subject of recommendations shared here to ideas that would facilitate more bills getting hearings and more bipartisanship to take place in the process of lawmaking. (During the idea-collection process we heard of many other good ideas that fall outside this scope. We will share those in another engagement.)

Methodology

The bill authors in the committee graphs are authorship as of the hearing date. (If an author was added or removed the same day as a hearing, we took that change as of the hearing - whether or not the floor session happened before or after the committee meeting.)

Hearings in the Rules committees were not included in the report because bill referrals to those committees operate differently than the policy and finance committees.

Some bills were counted multiple times because of multiple hearings across committees.

The graphs illustrating Senate bills will not have any bills in the 1-19% or 81-99% categories, because of the mathematical limits of 5 bill authors or less. These categories only apply to House bills.

Committees and individual legislators are presented in alphabetical order. Two members of the House resigned and were replaced during the interim. We left their information in the dataset, because their information is not removed by the Revisor's office. Two new members were elected and sworn into office to replace them. We did not delegate their predecessors' information to them – all of their authorship of bills reflects the action they took as members.

Authorship is based on information contained on the Minnesota legislative website, which is populated by information from the Revisor's office, and the House and Senate staff.

Hearings information is based on information publicly published in committee minutes, bill status spreadsheets, and individual bill information on the Minnesota Legislature website.

Methodology changes since 2023

On the committee pages:

- Bills that were heard the same committee in both 2023 and 2024 are counted individually in each year's hearing total.*
- Bills that were not formally referred to a committee but that were given a hearing are not counted in the referral total but are counted in the hearing total.*

On the individual legislator pages:

- 2023 numbers are as of adjournment of the 2023 session.
- 2024 and total numbers are as of adjournment sine die.
- Because the Minnesota legislature operates in a two-year biennium, bills that did not pass by 2023 adjournment were still viable until the legislature adjourned sine die in 2024. Due to changes made to bill authorship throughout the biennium (such as co-authors being added or subtracted) the final biennial totals are not always the sum of individual years. *

How the report has changed since 2023:

- Most graphs are presented numerically instead of by percentage. Percentages for each subsection of data can be found in the narrative on each page. The exception to this are the graphs reflecting percentage change in minority-led and bipartisan bills getting hearings (p 25-28 in this report) between the two years of the biennium.
- The full-page comparison graphs for all of the committees and all legislators (p 22-23, 43-44, 78-87, 89-108 in the 2023 report) were determined to be unnecessary so they were not recreated for this year's report.

*Figures on the committee and individual pages where these situations have occurred are marked with an asterisk and footnoted at the bottom of each page.
